


mother" of our present sector. In fact, it was she who suggested the names Du-Haut-de-I'Isle and I'Entrefilet when our sector was first created in April of 2015.


It has already been 4 years, and we will celebrate our 5th anniversary at the next general assembly on April 7th, 2020.

I am the new person responsible for the Insurance committee in our Haut-del'isle sector. Responsible is a big word. I see two main areas in this file: the first is to attend information meetings about our insurance coverage and report back to our members, and the second is to answer your questions. That does not make me an expert, but rather a link in the information chain.


I attended my first information meeting on the 22nd of March, 2019. I found out that LaPersonelle is the insurance company that offers AREQ members house and auto insurance with low fees and excellent service.


Every year when my insurance contract is set to renew, I receive numerous offers from various insurers. My spouse and I have a house, a condo and two cars. And each year, I ask the company soliciting my business for a quote. Up until now, without exception, their price is hundreds of dollars more than what I was already paying.

So, in order to test the system, I decided this year to ask LaPersonelle to study my file. Surprisingly, their offer was several hundred dollars below what I have been paying with my current insurer. I therefore decided to insure my property with this company.

Conclusion: make your own enquiries and you will see in your case whether it makes sense to change insurers or not. Phone LaPersonelle at 1-888-476-8737. The CSQ chose LaPersonelle, the largest group insurer in Quebec, and has been partnered with them for the last 33 years.

Now to address one of your questions, "If I go to Ottawa or Nova Scotia, am I covered by the ASSUREQ travel insurance?" Here is the answer from the company: all trips outside of Quebec are treated in the same way. So, whether you travel to France, Ontario or the United States etc., you are covered by the ASSSUREQ travel insurance. If you have any questions about your health insurance coverage while travelling, call CanAssistance before you leave at 1-800-465-2928.

But what about our coverage with RAMQ if we travel outside of Canada? RAMQ is applicable in the other provinces but with the following three restrictions:

Medication is not covered

- 2) Ambulance costs are not covered and
- 3) RAMQ will reimburse health service costs up to the amount that would be covered in Quebec (you have to pay the difference).

Remember that these costs are covered if you were approved for a trip outside Quebec.





The Federal elections are coming this October. As in every election, the parties tackle the current issues, among them, the environment.

The four main political parties have each presented their vision and action plan on the environment. It is up to us to choose on voting day.

As you are aware, there are several hot button issues concerning the environment: forests, water, earth, the wildlife on the earth and in the water, energy resources, and of course, atmospheric quality. Concerning the atmosphere, we cannot ignore the greenhouse gas effect (GHG).

What does the NDP, whose leader is Jagmeet Singh, say?


The NDP would keep the carbon tax that the Liberals have put in place, and they would put an end to oil and gas subsidies; as would the Green Party.


What does the Green Party's leader, Elizabeth May say?

Obviously, they support the carbon tax. In the opinion of the party and many experts, the carbon tax is the most efficient economic tool to reduce greenhouse gas emissions and to diminish the negative impact of climate change.

And what does the Conservative Party, led by Andrew Scheer say?

Well obviously, they are against the carbon tax - their party does not want to add additional taxes to Canadians in order to finance their environmental plan. However, their party agrees with the Paris accord concerning climate change. They do not say how they would reach the targets of the Paris accord other than by investing in new technologies and relying on incentives for individual consumers. (Personally, I don't believe them!)


On the other hand, Andrew Scheer's main goal is to defend workers in the Canadian energy sector. His real motivation is to exploit the tar sands to the maximum even though they have turned out to be more polluting than was previously thought! (see article published by Radio Canada April 23, 2019)

And finally, what is the position of the Trudeau Liberals?

As far back as 2002, the Liberal government under Jean Chrétien, announced its intention to ratify the Kyoto accord for Canada; which, by the way, was done.

Since that time the Liberals have always ratified climate change accords despite the fact that they do not respect the GHG emission reduction targets. Nevertheless, it remains that Justin Trudeau and his government have implemented the carbon tax and rebates in the whole of Canada despite the vigorous opposition from several provinces. In fact, the opposition and litigation are far from over. And yet this hasn't stopped them from buying the Tran Mountain pipeline! So, when will there be a transition away from fossil fuels? Knowing that fossil fuels have been and continue to be the driver of our economic development, wouldn't it be wise to use all the means necessary to constrain its harmful effects?

When you go to vote in October, it will be up to us to vote in the party that will do the most to reconcile the economy and the environment.


PLAYING TO HELP
